## WCTF Report:

We have met with all three middle schools about what we have done and what we could plan to do in the future if we have continued DFC funding. Krista is going to be delivering a permanent drop box to Mercy in Forest City. We are meeting our goals for prescription drugs. We need to spend more time on marijuana. The school district's Iowa Youth Survey results are back and we have them. Forest City and Lake Mills' results are even or consistent with previous years. North Iowa had increased rates with access to alcohol, perception of risk of harm of marijuana.
